These Terms and Conditions are applicable to all third -party Suppliers who build's and deliver Apps/App(s) to The Litium Platform and Litium App Cloud.

By entering into the Public App Partner Agreement, or by using Litium App Cloud for App distribution, the Partner accepts these Litium Public App Terms and Conditions.

App development Guidelines/Policy

- 1.1. The Partner accepts to adhere to Litium's App Development Guideline stated on docs.litium.com and, if required for the App, any 3rd party documentation.
- 1.2. The principles for development and maintenance of the App (s) shall follow so called best practice and de facto standards.
- 1.3. The Partner shall use and create architecture and documentation of the App in a manner which makes it easy for Litium, the Partner, Litium Solution Partners and Litium Customers to independently implement, test, use, extend and support the App.
- 1.4. Detailed design, source code, functional and technical descriptions of the App shall be presented by the Partner to Litium and these descriptions shall be approved by Litium before the responsibilities of Litium, under this Agreement, enters into force.
- 1.5. The Partner is responsible to ensure, during the full duration of this Agreement, that no development or action interferes with, damages, or accesses or uses any unauthorized manner the hardware, software, networks, technologies or other properties or services of Litium or of any end user or other 3rd parties. In addition, the Partner shall ensure that no law or regulation is violated and agrees not to disparage or devalue Litium or the App(s) directly or indirectly in regard to the development and during the life cycle of the App(s).
